We wish to inform you that the board of directors of Pictet (the “Fund”) has decided to divide the net asset value per share of certain share classes of the Compartment by ten (10) and consequently multiply by ten (10) the number of outstanding shares. This decision is taken to avoid recurrent marketing difficulties caused by the fact that the net asset value per share is very high.

This split will be done based on your position for the net asset value calculated as at **18 June 2021**. The number of shares you will be holding as at the net asset value calculated as at 18 June 2021, including orders received for the net asset value calculated as at that day, will be multiplied by 10, while the net asset value of each share will be divided by 10.

An updated statement of holding will be sent to shareholders after the split.

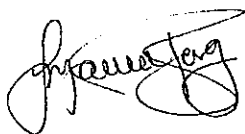
If you send an order expressed in number of shares, please see below how these orders will be treated:

Cut-off time	Number of shares	Net asset value applied	Example for a net asset value amounting to 1352.45 euros
Orders received before 1pm on 18 June 2021	100 shares	Net asset value BEFORE split	$100 \times 1352.45 = 135\,245$ Euros
Orders received after 1pm on 18 June 2021	100 shares	Net asset value AFTER split	$100 \times 135.24 = 13\,524$ Euros

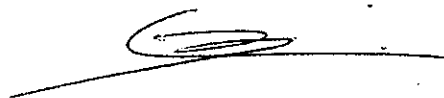
This split will not have any significant negative impact on your holding. However, if you do not agree to this change, you may request the redemption of your shares, free of redemption fees, up to the net asset value calculated as at 17 June 2021.
